 - d. Title of photo

GUIDELINES

1. Entries must be photographs. Visual or graphic art manipulations will not be accepted.
2. Images must be in "jpg" format.
3. Photographs will be accepted only from the original photographer. The photographer must hold the copyright to all photos submitted to the contest. Photographs that violate the laws of copyright will be disqualified. The use of public domain images is prohibited.
4. You may not excessively alter or change your photograph using photo editing software. Minor adjustments, including spotting, dodging and burning, sharpening, contrast and slight color adjustment or the digital equivalents are acceptable.
5. Photos must be in digital format. No print or film submissions will be accepted. Photos must be free of profane language, violence, nudity or personal attacks on people or organizations.
6. Photos must not violate copyright laws or use brand names or logos. You agree to indemnify Shuyler Productions for any claim, demand, judgment, or other allegation arising from your possible violation of someone's trademark, copyright or other legally protected interest in any way in your photo.
